### Point No.3

**Review of the notices displayed and action taken on directives/notifications received from authorities.**

It was brought to the notice of the committee members that a notice enclosing Disciplinary Rules was displayed on the Main Notice Board as well as on Library Notice Boards.

Also wide publicity is already given to the main provisions of the Maharashtra Anti-Ragging Act of 1999 and also the punishments for Ragging in the Institution. The Printed Flex-Boards are affixed in the main porch and at visible sites of each building in the academic complex as well as in the Boys & Girls Hostel premises.

It was also brought to the notice of the committee that, we have received communications from Authorities regarding submission of online affidavits from students and parents. The communications include -

- (1) UGC Circular dated 27/10/2021, 30/12/2021 & 11/01/2022;
- (2) Solapur University's letter No.SUS/DSW/8802 dated 02/12/2021;
- (3) Solapur University's letter No.SUS/DSW/403 dated 06/01/2022,
- (4) Solapur University's letter No.PAHSUS/DSW/2021-22/5046 dated 09/08/2023 accompanied by UGC notification No.F.No.1-15/2009ARC)PT-III dated 12<sup>th</sup> June 2023 also.

Copies of relevant circulars were displayed on student notice board/s from time to time.

**Programmes Conducted & action taken on directives/notifications received from authorities. :**

As per communication received from Solapur University vide letter No.PAHSUS/DSD/2023/4370 dated 14 July 2023 accompanied by UGC notification No.DO No.F.1-74/2016(ARC) dated 5<sup>th</sup> July, 2023, it was directed to observe "Anti-Ragging Day" on 12<sup>th</sup> August followed by "Anti-Ragging week from 12<sup>th</sup> August to 18<sup>th</sup> August" every year.

Accordingly, as per guidelines issued in the notifications we have conducted Orientation/ Introduction Programme on Anti-Ragging on 12<sup>th</sup> August, 2023 by observing "Anti-Ragging Day". A lecture was conducted in Room No.1 wherein faculty and students participated. Also slogan & essay writing and poster making competition was conducted during Anti-Ragging Week (12<sup>th</sup> August 2023 to 18<sup>th</sup> August 2023). Students have actively participated in these competitions and have made it successful. The response received from students was satisfactory. Copy of notice displayed is kept on record.

The All India Council for Technical Education (AICTE) has issued directives vide notification No. F.No.25-AICTE/AR/Antiragging/2023 dated 11<sup>th</sup> October 2023, for steps to be taken for curbing the menace of ragging in the AICTE approved institutions. Principal Dr.S.K.Shah narrated that, our institution has complied with the setting up Anti-Ragging Mechanism by way of adequate publicity through various mediums such as : Constitutio of Anti-Ragging Committee and Anti-Ragging Squad; Installing CCTV Cameras at vital points, conducting guidance lectures on eradication of ragging; updating website with contact details of Nodal Officers related to ARC; regular interaction and counseling with the students; identification of trouble-triggers; preparation and publication of e-admission booklet/ brochure giving detailed guidance to admitted students in the case of ragging; surprise visits for inspection of hostels, canteens, toilets, parking area, for preventing/quelling ragging and any uncaled for behavior; display of anti-ragging posters/banners at all conspicuous places at major places and notice boards; providing helpline numbers an website information to all students/parents/guardians to make them aware of anti-ragging etc.

Committee members noted the same.
