As on date @ 35 candidates have applied for this scheme. The approval and sanction of these applications is in process.

For welfare of the Backward Class Students, complete set of books from library are issued as per demand from students.

Information on various notices displayed for students belonging to various categories and claiming freeship/ scholarships/ merit-cum-means scholarship of the State & Central Government, EBC scheme etc. was given to the members. Xerox copies of these notices were placed on record.

From the academic session commenced from July-2011 the Government of Maharashtra has introduced a scheme for filling up of the Scholarship forms through ONLINE only. This scheme is applicable for UG and PG programmes also. The online submission of application is required to be made by the beneficiaries through the

Our Hirachand Nemchand College of Commerce, Solapur being a minority institution within the meaning of Article 31(1) of the Constitution of India, the rules regarding reservation, maintaining roaster, publication of advertisement for recruitments etc., are not applicable.
